#### **BASIC PURPOSE OF THE ROLE**

The Operational Buyer role involves purchasing equipment, materials and services from suppliers as required for various TAQA Departments and Stakeholders and is responsible for the complete PR/PO process. Acts as the last barrier before final commitment.

Responsible for the management and administration of Purchase Orders ensuring that the organization selects the most appropriate goods and services on the basis of price, quality, delivery times and services support.

### **KEY RESPONSIBILITIES**

- Resolves day-to-day issues and identifies opportunities for continuous improvement related to Supply Chain.
- Build and maintaining strong supplier relationships to secure the best possible price and service levels.
- Achieve cost savings through supplier negotiations, register savings and try to maximize.
- Create opportunities to improve the supplier base by working with suppliers to identify and develop innovative ideas.
- Dealing with all aspects of supplier quality problems and taking preventative action in the event of actual problems.
- Maintaining a close working relationship with other departments.
- To provide support, explanation of good practices and policies, etc. according to supply chain policies and procedures to stakeholders outside of the supply chain organisation to ensure compliance.
- Process Purchase Requests (PR) from internal stakeholders.
- Liaise with stakeholder regarding specifications or any specific quality requirements, documentation etc.
- Request quotations from vendors in accordance with guidelines, policies and procedures.
- Expedite Purchase Orders (PO) for timely delivery in consultation with internal stakeholders.
- Ensure most economical solution and timely delivery of purchased materials / services.
- Maintain purchasing data in computerized maintenance management system.
- Assist when required members of the Supply Chain department.
- Reports and takes initiative regarding possible process improvements within the supply chain, for purchasing and logistics.
- Perform any other duties, which may reasonably be associated with the job in order to meet the needs of the company.
